10. The vendor will provide operational manuals, OEM documents for peripherals, set of diagnostics to test all the sub-systems etc. along with the systems.
11. The delivery of above equipments will be at the National Institute of Science Education and Research, JATNI., Khurda, which is about 30 km away from Bhubaneswar on NH-5
13. The prices quoted in the technical/financial bid should be inclusive of power cables, interface cables, packing, forwarding, freight upto NISER, JATNI, transit insurance charges at sites.
