As you are aware, the National Council of Educational Research and Training (NCERT) is an apex organisation under Ministry of Human Resource Development (MHRD), Government of India. It assumes the responsibility of advising and assisting the Central and State Governments on policies and programmes for qualitative improvement in school education. The NCERT functions through its eight institutions located in different parts of the country viz., National Institute of Education (NIE), consisting of 18 Departments/ Divisions/Cells at New Delhi; five Regional Institutes of Education (RIEs) located at Ajmer, Bhopal, Bhubaneswar, Mysore and Shillong; two central institutions namely, Pandit Sunderlal Sharma Central Institute of Vocational Education (PSSCIVE) at Bhopal and Central Institute of Educational Technology (CIET) at New Delhi.

- to consider the programme proposals submitted by Institute/ Department/ Division/ Cell in the light of its role and functions.
- to recommend the programme proposals considered suitable by the IAB/DAB to Academic Committee (AC)/Management Committee (MC)

It gives me great pleasure in informing you that the Director, NCERT, recognising your experience and expertise in the area, has nominated you as an esteemed member of the IAB/DAB of NCERT constituents for a period of three years i.e. 2017-2020.

The meetings of the DABs/IABs for discussing the programme proposals for the year 2018-19 shall be conducted in December 2017 and January 2018. Joint Director/Principal of respective Institute/Head of the Department of NIE constituents shall be approaching you soon in this regard. It is hoped that your fruitful interventions will help in formulating relevant proposals and enhance the quality of the programmes.
